

CORRIGENDUM

Sub.:- Accreditation of Entrepreneurship Development Programme (EDP) centers under PMEGP – regarding.

Ref:1. Circular No.PMEGP/Cir.Guide/B&FL/2013-14/673 dated 23.09/29.10.2013.

2. Corrigendum of even No. dated 28.5.2014.

In partial modification of the above referred Circular dated 23.9/29.10.2013 in point No.III (e) in respect of method of selection pertaining to accreditation of entrepreneurship development programme (EDP) training centers/institutions under PMEGP scheme at field level had been revised vide above referred Corrigendum dated 28.05.2014. In point No.2 of the Corrigendum has mentioned that, the Zonal Dy. CEO shall finalize the proposal initiated for accreditation by the State Director with the approval/concurrence of Zonal member.

In this regard in view of dissolution of the Commission it is decided that, the power of according approval for accreditation may now be vested with Dy. CEO of the concerned Zone, based on the recommendation of the concerned State Director after 100% physical verification of the institutions and ensuring that it is fulfilling the norms and requirement as per EDP guidelines.

Further the following time lines may also be followed for each activity as detailed below.

- Time for verification of the institution by State/Divisional Director or its officials 30 days.
- ii) Time for recommendation to Zonal Dy. CEO by State/Divisional Director 5 days.
- iii) Examination and approval by Zonal Dy. CEO one week.

All other terms and conditions of the above reference Circular dated 23.09/29.10.2013 remain unchanged.

The above decision may be brought to the notice of all concerned for compliance.
