CIRCULAR

Sub: Display of Sign Board by PMEGP beneficiaries at main Entrance of project site- reg.

As per the PMEGP scheme guidelines published in booklet "Road to Pride and Progress" para 11 (t) Banks/KVIC/KVIB/DICs have to ensure that each beneficiary promptly displays the following signboard at the main entrance of his/her product slide.

(Unit Name)
Financed By(Bank), District Name Under
Prime Minister's Employment Generation Programme (PMEGP)
Ministry of Micro, Small and Medium Enterprises

- 3. However, instances have been noticed that many PMEGP units/entrepreneurs have not installed the sign board at the entrance of the site of unit/enterprises, despite time and again communication in this regard has already been given.
- 4. Hence it is directed that the physical verification team should check this aspect of display of prescribed sign board and also take the photographs of the same which needs to be submitted alongwith physical verification. These photographs can then be uploaded to the Khadi website alongwith address of the beneficiary. State/Divisional Directors while conducting sample purchase of units as per existing guidelines should also check this aspect of display of signboards as per the guidelines.

5. Since the interaction with the beneficiaries take place during the EDP system this aspect may be highlighted in the EDP programme and also during State Level workshops/exhibitions etc. State/Divisional Directors should also being the contents of the above directions to all the stake holders including banks, KVIC/KVIB/DIC, SLMC and SLBC for information and necessary. Zonal Dy. CEO may monitor the compliance.
