### **CIRCULAR**

Sub: Addendum to the Circular No. PMEGP/BFL/CIR Guidelines/2020-21 dated 16.10.2020.

It is to inform that the option of online EDP has already been introduced by KVIC since inception and the update is being made from time to time. As per the EDP circular dated 16.10.2020, online EDP training is being conducted for PMEGP beneficiaries and the beneficiary can opt for either pre-sanction EDP or post-sanction EDP training either through offline or online.Pre-sanction EDP training completed by the PMEGP beneficiaries through online EDP portal (Samadhan Portal) is valid and it should be considered at par with post-sanction EDP training as the content of syllabus is one and the same.

- 1. Moreover, the facility of pre-sanction EDP was provided by KVIC on payment for the convenience of the prospective entrepreneurs as it normally takes minimum two months time from the stage of application to sanction of the project by the bank under PMEGP.
- 2.It is observed that EDP certificates issued for pre-sanction EDP training through online EDP portal (Samadhan portal) are not considered by someof the Implementing agencies and Financing Banks.
- 3. It is therefore directed to consider the pre-sanction EDP training certificates issued to the PMEGP beneficiaries through online portal (Samadhan portal) as a valid proof of EDP training.

A sample of pre-sanction EDP certificate is enclosed herewith at Annexure-I for ready reference.
