CIRCULAR

Sub: Centralization of online EDP payment towards training under PMEGP.

This has reference to the circular bearing No. PMEGP/BFL/EDP/De-cent/2022-23 dated 09.05.2022 through which the guidelines for implementation of online EDP training & monitoring under PMEGP was conveyed.

The online EDP training program & PMEGP portal were integrated for data sharing & to generate online certificate on completion of training by beneficiaries. The applications are being generated & scrutinized and forwarded to financing bank by respective implementing agencies at field level. The bank takes credit decision & generate margin money claim on the portal which comes to KVIC head office directly. The offline EDP training is being organized & monitored by field offices in coordination with the respective training centres which provides checks and balance by the implementing agencies from where the application originated. The flow of information of online EDP training was decentralized to State/Divisional offices of KVIC for effective participation & proper check & balance of online EDP training at

par with the procedure adopted for offline EDP training & to release the payment to the training provider under B&FL budget allocated to the respective field offices with effect from 1st March 2022.

As per the decision taken in the Commission Meeting No. 696th dated 12.04.2023, the process of payment towards online EDP is centralized with the following modalities:-

- 1. The online EDP training provider in respect of the beneficiaries of all Implementing Agencies shall generate the statewise/officewise monthly invoice to State/Divisional offices of KVIC for release of payment. The online EDP training provider shall specify GST No. of KVIC, Head Office, Mumbai on the invoice enabling to process the payment.
- 2. The field offices of KVIC shall scrutiny, verify & validate the invoice uploaded by the online EDP training provider and recommend to Central office for release of payment.
- 3. Dte. Of PMEGP shall consolidate officewise payment on monthly basis as recommended by field offices for processing the payment.
- 4. This is applicable only to online EDP training and the process for offline EDP training system shall remain unchanged.
- 5. The State/Divisional offices shall process and settle the payment of the training completed till 31.03.2023 to the online training provider against the invoice received during the subsequent month.
- 6. This circular will be applicable for all the online EDP trainings completed from 1st April 2023.

In view of the above, State/Divisional Directors are requested to take note of this circular for compliance.
